

## **Example Endorsement Vote format for PTAs**

On February 10, 2022 the Issaquah School Board approved the following three (3) levies to put forward to voters on April 26, 2022. The levies are as follows:

(you may decide to read the entire following information or edit for your group)

(1) A four-year Educational Programs and Operations (EP&O) Levy renewal in the amounts of			
\$61,000,000 for collection in 2023	\$64,000,000 for collection in 2024		
\$67,000,000 for collection in 2025	\$70,000,000 for collection in 2026		

(2) A four-year Capital Levy renewal (with educational technology and critical repairs components) in the amounts of

\$31,472,000 for collection in 2023	\$35,957,000 for collection in 2024
\$36,561,000 for collection in 2025	\$37,320,000 for collection in 2026

(3) A one-year School Bus Levy in the amount of \$3,000,000 for collection in 2023.

You can ask if your membership would like to vote on an endorsement as a block of three or on each levy item individually. There are two examples here for either case.

"In order for our PTA to advocate for a yes vote for the replacement levies, we'll need to have an endorsement vote."				
(President can ask if there's a motion if one has not already being made)				
Sample motion language:				
"I move that the PTA/PTSA endorse the Issaquah School District's three (3) 2022 levies, the four-year EP&O renewal levy, the four-year Capital renewal levy and the one-year Bus levy, being put before the voters on April 26, 2022."				
After a motion, a 2nd, ask if there is any discussion; Discussion points can be found on separate document (see attached ISD levy fact sheet & information)				
If no discussion, or after discussion, call for the vote				
"All those in favor?	Any opposed?	Any abstentions?"		

Endorsing as a block of three (3)

## Endorsing individually will require that each levy have a motion, second and vote

"I move that the PTA/PTSA endorse the Issaquah School District's 2022 one-year Bus levy being put before the voters on April 26, 2022."
