

Volunteers for Issaquah Schools Bond Promotion Contest Agreement

This Agreement is entered into by and between Volunteers for Issaquah Schools, a Washington non-profit (the "Organizer") and the Participant whose name and signature appear below (the "Participant").

1. Purpose of the Contest

The Organizer is hosting a contest (the "Contest") for individuals to create and submit short videos, up to 45 seconds long, (the "Reel") to promote passage of Issaquah School Districts February 2025 bond (the "Campaign"). The winner of the Contest will receive a cash prize of \$500.

2. Eligibility

Participation is open to individuals aged 16 and up, and submission of an entry constitutes acceptance of the terms of this Agreement.

3. Submission Requirements

Participants must submit their Reels by January 11, 2025. Submissions must be targeted at helping pass the bond.

4. Ownership and Usage Rights

- a. By submitting a Reel, the Participant grants the Organizer a non-exclusive, royalty-free, worldwide license to use, reproduce, distribute, and display the Reel in connection with the Campaign, across any media platforms, now known or hereafter developed.
- b. The Participant warrants that the Reel is their original work and does not infringe upon any intellectual property rights of others.

5. Selection and Prize

- a. The winning Reel will be selected by a panel of judges appointed by the Organizer. The decision of the judges is final.
- b. The winner will receive a cash prize of \$500, payable within 20 days after the announcement of the winner.
- c. The submissions shall be emailed to volunteersforissaquahschools@gmail.com on or before midnight on January 11, 2005.

6. Indemnification

The Participant agrees to indemnify and hold harmless the Organizer from any claims, damages, or liabilities arising out of the use of their Reel.

7. Miscellaneous

- a. This Agreement is governed by the laws of the State of Washington.

b. Any disputes arising under this Agreement shall be resolved exclusively through JDR binding arbitration in Seattle Washington.

8. Contribution PDC Disclosure

You acknowledge that you are an amateur contributing the Reel for VIS to use in its campaign. If you are professional at creating social media content, you estimate the value of your Reel at \$_____. (If this is left blank, you acknowledge that you believe that Reel has no commercial value.)

9. Acknowledgment and Acceptance
